DOJI LABS PRIVACY POLICY

This Privacy Policy describes how Doji Labs, Inc. ("we", "us", "our") collects, uses and discloses information about you when you use our website (https://www.doji.com) (the "Website") and our related mobile application (the "App"). The Website and any content, tools, features and other functionalities offered on or through our Website and App are collectively referred to as the "Services" and "you" and "your" means you as the user of the Services. For the purposes of this Privacy Policy, we are the controller in respect of any personal information processed in connection with the Services.

Please read this Privacy Policy carefully. By using any of the Services, you agree to the collection, use, and disclosure of your information as described in this Privacy Policy. If you do not understand or agree to this Privacy Policy, please do not use or access the Services.

1. CHANGES TO THIS PRIVACY POLICY

We may modify this Privacy Policy from time to time, in which case we will update the "Last Updated" date at the top of this Privacy Policy. If we make material changes to how we use or disclose information we collect, we will use reasonable efforts to notify you (such as by emailing you at the last email address you provided us, by posting notice of such changes on the Website or App or by other means consistent with applicable law) and will take additional steps as required by applicable law. If you do not agree to any updates to this Privacy Policy, please do not continue using or accessing the Services.

2. COLLECTION AND USE OF INFORMATION

When you use or access the Services, we collect certain categories of information about you from a variety of sources. In addition to the specific uses discussed below, we may use this information to provide and improve the Services and to maintain our business relationship, including by enhancing the safety and security of our Services, providing customer support, complying with applicable legal obligations, enforcing any applicable terms of service, and protecting our rights and the rights of our employees, users or other individuals.

Information You Provide to Us

Some features of the Services may require you to directly provide certain information, including information about yourself. You may elect not to provide this information, but doing so may prevent you from using or accessing these features. Information that you directly submit through our Services is processed in order to perform our contract with you and includes:

- Contact information, such as your name, phone number, and email address.
- Account information, such as account handle and other information you add to your account. We use this information to create and maintain your account, provide the Services, and to communicate with you (including to tell you about products or services that may be of interest to you, provide you with offers or promotions, and respond to your queries). We use your telephone number as part of the account creation to send you an SMS code to verify ownership of the phone number. If you choose to purchase additional features or upgrade your account to a paid tier, we collect information about your account tier and transaction history. We do not collect your credit card information or other payment information, as this is all handled through the app store.

- Any information you choose to input into our AI-powered tools ("Input"), including photos of yourself, photos of or links to apparel items or other fashion products you wish to style, height and body measurements, and other information that you upload to generate and return new content as a part of the Services, such as your own personal digital avatar based on your image and likeness ("**Output**"). We may also use Input and Output in our legitimate interests to improve the Services, including by training or enhancing the models that power our Services to improve the quality of your custom avatar and the display of fashion products on your face) to create and maintain your personalized AI avatar to enable your virtual try-on features and fashion visualization. We do not use this data to try and identify you or to verify your identity. Your images are stored securely in our cloud infrastructure and are not shared with third parties other than our cloud provider. We retain your images for as long as you maintain an active account to continuously improve your avatar's accuracy and enable enhanced personalization features. You may object to this and request the deletion of your images at any time by contacting us at hi@doji.com, which will result in the deletion of your AI avatar.
- Any other information you choose to include in communications with us, which we use as described in this Privacy Policy or as otherwise disclosed at the time of collection.

Information Collected Automatically

We and third parties also automatically collect certain information about your interactions with the Services, including through cookies and other tracking technologies. Where required by applicable law, we obtain your consent to process this information. This information is collected and used to tailor your experience with the Services (such as to recommend different products and help you discover brands that you may like), run analytics, and better understand user interactions with and improve the Services. Such information includes:

- **Device information**, such as device type, operating system, unique device identifier, and internet protocol (IP) address.
- Location information, such as approximate location based on your IP address and, if you choose to provide it, precise geolocation of your device when you access the Services.
- Other information regarding your interaction with the Services, such as products and brands that you express an interest in, links that you click on and other clickstream data, log data, date and time stamps, browser type, interactions with marketing communications, and ad impressions.

Information Collected From Other Sources

We may obtain information about you from outside sources, including information that we collect directly from third parties and information from third parties that you choose to share with us. Such information includes:

• Information we receive from login integration partners, such as when you access the Services through Facebook or Google, which we use to maintain your account and login information. These partners provide information such as your name, email address, and additional account information that is publicly accessible.

- **Business partners**, including clothing merchants or fashion brands that you may use the Services to access or purchase products from. These partners may provide confirmation that you made a purchase of their product and provide other basic information about your order (such as the value of it and the product purchased), but we do not receive or handle any of your payment information. We use this information to manage our relationship with users and business partners, to help us make more informed product recommendations, and to better understand user interactions with the Services.
- Information we receive from social media platforms, such as when you interact with us on Instagram or TikTok, which we use to communicate with you and personalize our Services.

Any information we receive from outside sources will be treated in accordance with this Privacy Policy. We are not responsible for the accuracy of the information provided to us by third parties and are not responsible for any third party's policies or practices. Deidentified Information

Finally, we may deidentify your information such that it cannot reasonably be used to infer information about you or otherwise be linked to you (or we may collect information that has already been deidentified), and we may use such deidentified information for any purpose.

3. DISCLOSURE OF YOUR INFORMATION

We may disclose your information for legitimate purposes subject to this Privacy Policy, including the following categories of third parties:

- Vendors or other service providers who help us provide the Services in order to perform our contract with you and in our legitimate interests, including for analytics, system administration, cloud storage, security, customer relationship management, marketing communications, and the deployment of Tracking Technologies.
- Business partners, such as clothing merchants and fashion brands whose products you may access through the Services, with your consent where required by applicable law.
- Our affiliates or others within our corporate group, in our legitimate interests.
- Third parties with your consent when you request or direct us to disclose information, such as through your use of login integration.
- Professional advisors, such as auditors, law firms, or accounting firms in our legitimate interests or where required by applicable law.
- Third parties in connection with or anticipation of an asset sale, merger, bankruptcy, or other business transaction in our legitimate interests.

We may also disclose your information as needed to comply with applicable law or any obligations thereunder or to cooperate with law enforcement, judicial orders, and regulatory inquiries, to enforce any applicable terms of service, and to ensure the safety and security of our business, employees, and users.

The information that we collect from you may be accessed from, transferred to, and stored and used in countries outside the country in which you are located. We will take all steps reasonably necessary to ensure that your information is treated securely and in accordance with this Privacy Policy.

Transfers of data outside the European Economic Area (EEA) or the UK to a country that has not been determined as "adequate" by the European Commission (EC) or UK authorities will be governed by the EC's standard contractual clauses for the transfer of personal data to third countries or the UK Information Commissioner's international data transfer addendum to the EU standard contractual clauses (as applicable). 4. COOKIES AND OTHER TRACKING TECHNOLOGIES

We and third parties may use tracking technologies, including cookies and pixels, to collect information about your browsing activities on the Website. Most browsers accept cookies automatically, but you may be able to control the way in which your devices permit the use of cookies. If you so choose, you may block or delete certain of our cookies from your browser; however, blocking or deleting cookies may cause some features of the Website, including any portal features and general functionality, to work incorrectly.

Your browser settings may also allow you to transmit a "Do Not Track" signal when you visit various websites. Like many websites, our Website is not designed to respond to "Do Not Track" signals received from browsers.

5. SOCIAL FEATURES

Certain features of the Services allow you to initiate interactions between the Services and third-party services or platforms, such as social networks ("**Social Features**"). Social Features may include features that allow you to access our pages on third-party platforms, and from there to "like" or "share" our content. Use of Social Features may allow a third party to collect and/or use your information. If you use Social Features, information you post or make accessible may be publicly displayed by the third-party service. Both we and the third party may have access to information about you and your use of both the Services and the third-party service. Our inclusion of such links does not, by itself, imply any endorsement of the content on such platforms or of their owners or operators.

7. RIGHTS

Depending on where you live, you may have certain rights in relation to your information:

- Access. The right to access the information we hold about you, how we use it, and who we share it with.
- **Portability**. The right to receive a copy of certain information we hold about you and to request that we transfer it to a third party.
- Correction. The right to correct your information we hold that is inaccurate.
- **Erasure**. The right to delete the information we hold about you.
- **Restriction of processing to storage only**. The right to require us to stop processing the information we hold about you, other than for storage purposes.
- **Objection**. The right to object to our processing of your information.
- **Objection to marketing**. The right to object to marketing at any time by opting-out using the unsubscribe/opt-out function displayed in our communications to you or by emailing hi@doji.com.
- Withdrawal of consent. Where we rely on consent to process your information, you have the right to withdraw this consent at any time by emailing hi@doji.com.

Please note that a number of these rights only apply in certain circumstances, and all of these rights may be limited by law. For example, if fulfilling your request would adversely affect other individuals or our trade secrets or intellectual property, if there are overriding public interests or if we are required by law to retain your information.

If we become aware that we have unknowingly collected information about a child, in particular any child under 13 years of age, we will make commercially reasonable efforts to delete such information from our database. 9. DATA RETENTION

We will a retain and use your information based on our consideration of various criteria, including whether we need the information to continue providing you the Services, comply with our legal obligations, resolve disputes, enforce our contractual agreements and our policies, prevent harm, promote safety, security and integrity, and to protect or defend the Services, our rights, the rights of our users, or others. As set out above, we may store your information in a deidentified / anonymized or aggregated format; we may use this information indefinitely without further notice to you.

10. DATA SECURITY

Despite our reasonable efforts to protect your information, no security measures are impenetrable, and we cannot guarantee "perfect security." Any information you send to us electronically, while using the Services or otherwise interacting with us, may not be secure while in transit. We recommend that you do not use unsecure channels to send us sensitive or confidential information.
